Applications are invited from Indian Citizen in Standard form (as prescribed in the first page of IX of Assam Gazette) for filling up of one temporary post of Driver (Grade- III) Un-Reserved in the office of the Member, Foreigners' Tribunal, Tezpur.

The post shall be filled in compliance with the AFRBM Act/2005, the Reservation Act and all other rules/ formalities as well as directions of Hon'ble Supreme Court/ High Courts etc.

All backlogs in respect of SC/ST and those appointments that is required to be made in compliance with specific directions/ orders of Hon'ble Courts shall be given first priority by the appointing authority.

Appointments on compassionate grounds, if any, also be made within the number of posts approved as above after following the directions of the Hon'ble Court/ relevant OMs and having regard to the direction of Hon'ble High Court in WP © No. 3875/2005, now procedure set thereof, and approval of the Committees constituted for the purpose as required. Women Reservation, Physically Handicapped persons will be as per Rule.

The candidates must have registered their names in the Employment Exchange and the registration numbers must be mentioned with the date in their applications.

The candidates must not be less than 18 years of age and more than 38 years of age. Upper age limit is reliable for ST/ SC candidates as per rules as on 1st March/2010.

Qualification :- The candidates must have passed the HSLC examination from a recognized University or Board and candidates must possess a valid Medium Vehicle License.

Examination fee: - Rs. 5.00 (Rupees Five) only and Rs. 2.50 (Rupees Two and Fifty paise) only (in case of SC/ ST candidates) should be deposited under the head of account 0070- Other Administrative Service (examination fee etc.). The original copy of the Treasury Challan should be attached with the application form.

Completed application form along-with other supporting testimonials, copy of Treasury Challan, 3 (three) copies of recent passport size photograph should be submitted during the office hours in the office of the undersigned on or before **02.08.2010** along with self Address Envelope with Postal Stamp of Rs. 5/-

Application forms may also be submitted in the office of the Sub-Divisional Officer (Civil), Biswanath Sub- Division and Gohpur Sub- Division on or before the same day.

Eligible candidates will be asked to appear before the interview board (both oral and practical) which will be intimated later on. No T.A./ D.A. can be claimed for the same.
