The State Level Monitoring Committee (SLMC) will have the following functions:

- State Level Monitoring Committee shall be responsible for ensuring adherence to the specific conditions in respect of grant for local bodies, wherever applicable.
- Implementation of all conditions for local bodies including sixth schedule areas grant as recommended by Fifth Assam State Finance Commission.
- iii. To ensure proper utilization, efficiency, effectiveness, efforts at tapping revenue from own sources, promoting participatory process, enhancing transparency and accountability and submission of Utilization Certificates in time as per prescribed format of SFC Cell under Finance (EA) Department in order to enable Government of Assam to release next instalment.
- iv. State Level Monitoring Committee should examine the projects keeping in view the principal that the funds are used for asset creation like road, building, drinking water, village markets etc, intended to cover revenue gap.

- v. SLMC may suggest measures for reddressal of problem faced by local bodies and sixth schedule areas in respect of accounting and manpower for handling huge transfer of funds.
- vi. The committee shall be responsible for monitoring both financial and physical targets

vii. SLMC may consider and approve projects / schemes etc.

viii. State Level Monitoring Committee should oversee that the councils would ensure coverage of all villages /habitations as far as possible.

ix. District Level Monitoring Committees (both general and sixth schedule areas) may submit report to the Administrative Department concerned and placed list in the State Level Monitoring Committee.

x. The committee should meet at least twice every financial year to review the utilization of the grants.
